Having considered the Joint Stipulation of the Parties, and finding good cause therefore, IT IS HEREBY ORDERED that the Parties’ briefing schedule for Elysium’s Motion to Dismiss ChromaDex’s Fifth Amended Complaint is approved:

Defendant and Counterclaimant Elysium Health, Inc. (“Elysium”), Defendant Mark Morris (“Morris”), and Plaintiff and Counter-Defendant ChromaDex, Inc. (“ChromaDex”) (collectively referred to herein as the “Parties”), submit the following joint stipulation regarding the briefing schedule for Elysium and Morris’s Motions to Dismiss ChromaDex’s Fifth Amended Complaint (“Motions”).

On November 27, 2018, the Court granted ChromaDex’s Motion for Leave to File Fifth Amended Complaint (ECF No. 152). ChromaDex filed its Fifth Amended Complaint on November 27, 2018 (ECF No. 153). Elysium and Morris will move the Court for an order dismissing, in part, ChromaDex’s Fifth Amended Complaint.


The Parties have discussed the deadlines related to these Motions and have agreed that the Parties shall meet and confer pursuant to Local Rule 7-3 by December 14, 2018 and that Elysium and Morris shall file their Motions to Dismiss ChromaDex’s Fifth Amended Complaint on December 21, 2018. ChromaDex’s opposition briefs shall be filed on January 16, 2019. Elysium and Morris’s reply briefs shall be filed on January 25, 2019. The Parties shall
