PROCEEDINGS: (IN CHAMBERS) ORDER GRANTING STIPULATION TO AMEND THE COMPLAINT AND MODIFY THE SCHEDULING ORDER, (DKT. 107), AND DENYING APPLICATION TO FILE UNDER SEAL, (DKT. 105)

On June 22, 2018, the parties filed a joint stipulation to allow Plaintiff ChromaDex, Inc. to file a Fourth Amended Complaint and to modify the scheduling order to extend all applicable deadlines, including trial, by three months. (Dkt. 107.) The parties' stipulation is GRANTED. Plaintiff shall **FILE** the Fourth Amended Complaint as a separate docket entry by **June 29, 2018**. The parties shall meet and confer and **LODGE** a proposed modified scheduling order by **June 29, 2018**.

Plaintiff has also filed an application to file portions of the Fourth Amended Complaint under seal. (Dkt. 105.) This application is **DENIED**. Plaintiff does not provide good cause to file portions of its pleading under seal. Plaintiff merely states that it is required, under the parties' protective order, to file under seal portions that "summarize or reflect" information that Defendant Elysium Health, Inc. produced in discovery and designated as "Highly Confidential – Attorney's Eyes Only." Plaintiff provides no other justification for filing these portions of its pleading under seal, and does not even attempt to explain the harm that might result from public disclosure.
